Item 3 – Minutes of previous meeting

3.1 The minutes of the 19 July meeting were agreed. They actions are listed below:

Item 4 – LEP Transition Update

4.1 Steve Samson provided some background and an update on the LEP transition in the slides below:

LEP Transition Update

- 13 July: SELEP Board agreed to work toward slosure of the LEP by 31 March 2024
- 4 Aug: DLUHC guidance published 'Integration of LEP functions into local democratic institutions'
- Five SELEP working groupsset up to plan transition activity (UTLAs involved):
 - Growth Hub & Business Support
 - Partnerships & Network
 - Governance and Capital Programme
 - Resourcing
 - Data and Intelligence
- SELEP Transition Plan being developed for board endorsement on 13 October
- Kent & MedwayIntegration Plan under development
- Kent & Medway 'offer' to be presented to DLUHC
- Jan 2024: Further government guidance for local authorities
- March 2024– closure of SELEP with new arrangements in place from April 2024

Key Points from Government Guidance

- **Functions being transferred** Business representation, Strategic economic planning, Delivery of government programmes (where directed)
- The new geography will be <u>Kent & Medway</u>(functional economic area with population of 500,000+)
- <u>Continued role for KMEP</u>UTLAs to create or continue to engage with an Economic Growth Board made up of local business leaders and relevant representative bodies
- <u>Kent & Medway Economic Framework</u> areas encouraged to produce / update economic strategies to support local decision making and make the case for future access to government programmes
- Kent & Medway Growth Hub Government expects LAs to work to ensure seamless provision in future as a convening point for business support
- Growing Places Fund: Future management of GPF loan scheme should be agreed locally
- <u>Capital Programmes</u>: Essex CC as accountable body for SELEP to retain responsibility for future management of LGF & GBF programmes <u>to be challenged</u>)
- <u>Resources:</u> 'some revenue funding' to be provided to local authorities in 2024/25 to support delivery of LEP functions
- Liz Gibney asked for clarification on what it meant for 'the Future management of GPF loan scheme to be agreed locally'.
- Steve Samson replied that the current understanding is that there won't be any new GPF money. So it will be a case of looking at how any returned GPF monies (between 9 and 15million for the SELEP areas) can be used in Kent & Medway in future.
- There will be a proposal to the SELEP board in October as to how to apportion that amount between the Federated areas.
- The first step is that we secure an amount of funding for Kent and Medway, likely to be around £5m initially, but there will be future funding that comes back.
- KMEP needs to consider how it would like to manage that potentially as an Evergreen loan scheme going forwards. The assumption is this will be loans but SELEP is asking government whether it could include an element of grants as well.
- Conversation to be picked up in subsequent KMEP meetings as to what to do with that pot.

- Jo James said that taking on the SELEP staff is a good plan and their expertise should be utilised. Is there an opportunity to share resources across Kent and Medway so staff don't just work for Kent or they don't just work for Medway?
- Steve Samson confirmed this. There are currently eight people in the secretariat at SELEP open to new roles within local authorities, in Kent Medway, East Sussex or Essex. If two to three people came to KCC, we'd very much see that as a Kent and Medway role and similarly if any posts came to Medway.
- These roles could for example support sector groups/partnerships and networks; taking forwards actions from the economic strategy; and skills (looping in Kent Medway Employment Task Force).
- Also there could be a role supporting economic data intelligence.
- We will be competing with Essex and East Sussex to recruit key staff.
- There will be funding from SELEP coming across to accompany staff, but it will only be for a period of time (between 12 to 24 months)

- ٠ Steve Samson discussed the slide below adding that there are some 17 capital programme projects currently running until about 27/28 and KCC would be taking on responsibility for the financial management and the monitoring for anything relating to Growing Places Fund and loan based funding in the future.



- Cllr Edwards said that discussion so far had been positive and productive and added that, in more recent discussions, it was suggested that potentially one member of SELEP staff also came directly through to Medway, potentially focused on a data role.
- Cllr Edwards also asked about the proposed revenue support and when we might be able to give an update on timescales for this?
- Steve Samson answered that KCC could likely be allotted £100K from government to support LEP functions, although was not sure at this stage whether there would be any ring fencing for specific functions or whether it would be down to local areas to determine how we use that.
- Next steps, first draft of an integration plan that we can share with KMEP at the October meeting, so that everything can be put in place from April next year.
- Steve Samson mentioned that we need to nominate 2 board members from the private sector to join the SELEP investment panel which will meet on 1 Dec to make the funding decisions about the getting building fund allocations.
- David Milham nominated himself to do this.



- Steve Samson said that initially 19 expressions of interest were received, and 11 full business cases were submitted.
- Matthew Arnold asked how much do we realistically think would end up being allocated in a fair and equitable way to Kent and Medway?
- Steve Samson said that he would anticipate that somewhere in the region of around 800K to 1 million would be a fair portion for Kent and Medway.
- Liz Gibney said that she and colleagues had looked at the applications in terms of strategic projects that have the greatest benefit for the greatest number of people.
- The projects have been clustered: 5 good projects on business hub workspace and there could be a value in combining these together.
- Steve Samson then ran through each of the summary slides for the bids that were submitted by the applicants:

• Steve Samson ran through the 11 summaries of each bid. (Annexed)

- Cllr Alan Baldock asked why there were no business cases from port of Ramsgate and Chapel Down.
- Steve Samson said that these two projects had not been able to submit full business cases in the time available which was regrettable given the strategic nature of these particular proects.
- Vince Lucas asked has any been scoring been done against the criteria under which the GBF funds are allocated? As it would be best to put forward the ones that most closely match the funding criteria.
- Steve Samson said that those criteria would be assessed as part of the independent technical evaluation and at this moment we will be needing to make decisions based on the more general information we've got. SELEP's expectation is that we're looking at these projects primarily from a strategic economic point of view for Kent and Medway now.
- Liz Gibney said that today's aim is to get an agreement on our approach on how we will access the bids.
- Cllr Roger Gough said that KMEP have historically been good at having robust cases and that it would be good that we nonetheless can demonstrate that degree of rigor and to look at the strategic benefit for the projects .
- Cllr Roger Gough said he would like to have a better understanding of the delivery of the Dover Harbour Board Project.
- Cllr Roger Gough said it would be beneficial to rank the projects for future funding opportunities and look into the subtle differences in deliverability.
- Matthew Arnold wanted to echo Cllr Roger Gough's comments.
- Cllr Alan Baldock highlighted a potential heritage protection element for the Chatham Dockyard proposal which would repurpose an existing asset to create jobs and secure future income for the trust, which would be a win-win situation.
- Jo James mentioned that it was important to look at if the projects had enough reserves and funding to do this anyway.
- Jo James also said that strategic projects should be the priority.
- Regarding the business hubs it will be difficult to choose between them.
- Jo James said that we would have to look into the projects in more detail and prioritise.
- Liz Gibney suggested the need for a separate investment panel to evaluate the projects and to not conclude ranking today.

- Liz Gibney reiterated the point that at this stage all projects are of equal merit.
- Andrew Metcalf had a question about the A249 (answered by Steve Samson) and the Port of Dover technology project.
- Steve Samson said that regarding Dover there is another bid that KCC is currently working on for the Department for Science, Innovation, Technology which is focused on using new technologies to facilitate traffic management and monitoring to and from the Channel ports/Tunnel in particular. The GBF request is about putting infrastructure in place at Dover where better connectivity is already required but that will unlock potential for future tech solutions. The other bid that Dover is working on with KCC and with Thames Estuary, will be a bid that covers all of Kent Midways ports and a few of those north of the Thames as well.
- Regarding the A249 Bearsted Road project, a package of funding is in place worth £16.3m with the £500K GBF request required to tackle increased costs due to inflation. The KMEP investment panel would need to verify whether the other sources of funding and the wider scheme would be at risk without the GBF.
- David Milham FSB asked if it might be worth prioritising projects that may not attract funding elsewhere as those projects would be at risk of not proceeding.
- Vince Lucas reiterated the need for a subgroup that, informed with the criteria can make decisions and offered to work with KCC to draft Kent & Medway Selection Criteria.
- Liz Gibney established by show of hands that an investment panel to look into the bids in more detail should be established. This will be held on 19 September. The projects will then need to go through an ITE and there is a need for KCC's Director of Finance to sign a 'Section 151' letter of support before 22 September.
- Liz Gibney also established by show of hands that there is a value in prioritising strategic projects.
- Liz Gibney acknowledged that as a group it is being consistently said that the five schemes of similar type, which are the business hub type, seem to be of value and should board members should consider the links between them. Then possibly put forward a case for them potentially now, but also to look at them going forward in the future for when other funding of other types become available.

ACITON: KMEP Board Members to fill out ranking poll survey for the prioritisation of projects by before the investment panel meets on 19 September.

- Jo Nolan said that it was also important to consider employment opportunities, the value of the whole investment and the carbon impact.
- Matthew Arnold asked further questions of the A249 project and whether it was at risk of being held up.
- Steve Samson said he could get clarity from colleagues.
- Cllr Thornton, Julia said it was important to really assess the shovel readiness if planning permissions are required.
- Cllr Roger Gough said that a deepened reality check is important.
- Cllr Ben Chapelard said that he felt the big projects should be funded by central government.
- Cllr Lauren Edwards questioned the categorisation of certain project which could be picked up offline and would expect a an assurance that Medway will be represented in these discussions.
- Liz Gibney then established that during the call the following Board Members put their names forward to be on the investment panel.

Action: Steve to circulate ranking survey, projects business cases, clarify assessment criteria to be considered and send invitation for KMEP investment panel meeting

Action: Steve to alert KCC Director of finance to this meeting as they will have to sign a Section 151 letter on the projects put forward by the panel by 22 September.
